OurGV Rewards Non-Profit Participant Terms and Conditions

OurGV Rewards goal is to create the most effective fundraising opportunity for non-profit groups. Accordingly, there are standards to being a part of the program. These Terms and Conditions constitute the entire agreement between OurGV Rewards and Non-Profit Participant (NPP):

1. NPP shall operate in a manner consistent with their stated mission.
2. NPP shall not engage in, support, or be publicly associated with any activity that is illegal, unethical, or immoral.
3. OurGV Rewards reserves the right to reject, suspend, or terminate a NPP at our discretion.
4. OurGV Rewards shall keep confidential customer registration data unless otherwise authorized by customer.
5. No entry cost is necessary for a NPP or Customer to participate.
6. The acceptance of an NPP into OurGV Rewards is contingent on the receipt of a signed OurGV Rewards Non-Profit Agreement and acceptable non-profit documentation. In the United States, a document referencing 501 (c) (3) is preferable.
7. An NPP's share of the rebate is dependent on their Non-Profit Fundraising Solutions option. The designated percentage of the Fundraising Solutions rebate is applied to the merchant's posted rebate on the OurGV Mall site.
8. The rebates are paid quarterly to NPP.
9. The rebate totals are based on total dollar amount charged to the debit and/or credit card(s).
10. A reasonable effort is assumed from NPP in promoting the program to the degree matching its particular fundraising goals.
11. The designated contact person of the NPP shall have access to an information data center.
12. The term of this Agreement shall be for one (1) year and automatically renews for one additional year at each annual anniversary. NPP may cancel this Agreement with sixty (60) day written notice to OurGV Rewards.

13. OurGV Rewards and OurGV, Inc do not specifically endorse any of the NPPs or merchants that are part of the program.
14. OurGV Rewards shall not be liable for any failure to reach fundraising goals for the NPP.
15. All disputes between merchants and customers relating to any sale shall be settled between the merchant and customer.
16. OurGV Rewards and OurGV assume no responsibility for defects or errors in report generation caused by materially inaccurate, garble, defective or unusable transaction data received by the program from any source, including defects resulting from transmission or other failures not within the program's control.
17. OurGV Rewards may change, suspend, or discontinue all or any aspect of the program at any time without liability without notice.
18. In no event shall OurGV Rewards or OurGV, Inc be liable to the NPP for any incidental, punitive, consequential, indirect or special damages.
19. NPP agrees to indemnify, defend and hold harmless OurGV Rewards, OurGV Inc, its officers, owners, agents, employees, affiliates, licensors, and licensees from any and all liability and costs, including, without limitation, penalties, attorney's fees, and costs incurred in connection with any claim or suit brought by consumers, any claim arising from NPP activities, or any breach by NPP of these Terms and Conditions.
